Verification of Identity

Regulations require us to verify your identity. So that we can do this, please send us:

One of the following documents:

- Passport or Drivers licence
- Inland Revenue tax notification
- Firearms certificate
- Armed forces or National Identity Card (Police warrant card)

And one of these documents:

- Utility bill – excluding mobile phone bills (less than 6 months old)
- Council tax bill – current year only
- Bank or building society account or credit card statement (not storecard)
- Current mortgage statement

Certified copies of documents are acceptable. These must however, be certified with the words 'Originals seen – certified as a true copy of the original' by one of the following:

- Doctor
- Teacher
- Qualified Accountant
- Lawyer
- Banker
- Minister of Religion
- Postmaster

Certification must clearly include the certifying party's name, capacity, contact details, date of certification and be independent of the party concerned.

We will take copies of original identity documents and return them to you.
