If the request is made after 5:00 PM, it will be processed the next business day.</p> <p>For joint accounts, the request must follow the signing rules and be received before 5:00 PM to be processed on the same day.</p> <p>If you send a withdrawal request by post or email before 2:00 PM, the funds should reach your Nominated Bank Account on the same business day. 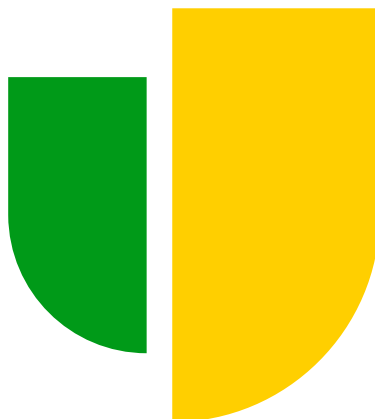
