Can I withdraw money?	No. Withdrawals, transfers or closures are not permitted before the maturity date. At the end of the fixed term of your account, in the absence of instructions being received from you, your funds will be reinvested into an easy access account with an interest rate at the Bank's prevailing rate for such accounts (this will be notified to you).
