Funds will be sent to your Nominated Bank Account upon withdrawal request.</p> <p><b>How to make a withdrawal:</b></p> <p>Once your account is open, you can make unlimited additional deposits from and withdrawals to your Nominated Bank Account, subject to the account maximum and minimum balance requirement for your account being met.</p> <p>A withdrawal request can be made via Online Banking, by email, in writing or using the contact us form on our website.</p> <p>Please confirm your name, account number, amount of withdrawal and confirmation of your nominated bank account.</p> <p>If you make a withdrawal request using online banking before 5:00 PM, the funds should reach your Nominated Bank Account on the same business day. If the request is made after 5:00 PM, it will be processed the next business day.</p> <p>The request must follow the signing rules and be received before 5:00 PM to be processed on the same day.</p> <p>If you send a withdrawal request by post or email before 2:00 PM, the funds should reach your Nominated Bank Account on the same business day. If the request is made after 2:00 PM, it will be processed the next business day.</p> <p>For more details, please refer to Sections E1.6 – E1.7 of the Terms and Conditions.</p>
